

Why should Italian firms consider Kentucky?




Each year hundreds of companies choose to locate or expand in Kentucky thanks to its low cost of doing business, skilled workforce, robust distribution and logistics industry and a geographical advantage putting it less than 1,000 km from 65 percent of the U.S. population.

Advanced Manufacturing

Kentucky has a strong and growing manufacturing industry made up of 4,500 firms contributing 19% to our GDP. The Financial Times 2018 fDi Report ranked Kentucky as the #1 destination for manufacturing projects. In the last three years, Kentucky has received over \$18.1 billion in new investment and 50,745 new jobs created from 1,101 different projects across a number of our target industry sectors. Global Logistics Capacity

Kentucky is a gateway between the South and Midwest with easy access to the Northeast and Atlantic Seaboard.

- 3rd nationally in air-cargo shipment volume with two air cargo hubs (UPS Worldport and DHL Americas hub)
- Amazon is locating their first Prime Air Shipping Hub in Northern Kentucky which will open in 2021.



Workforce Training & Education

Kentucky is in the midst of a workforce development revolution, working with businesses to increase the labor force and ensure Kentucky provides the most highly skilled and trained workforce in the US. Through the Kentucky Skills Network we provide companies access to a package of services including employee recruitment and customized skills training—at no charge. More than \$200 million has been invested into upgrading our workforce training facilities to ensure our labor force of over 2 million is trained for global quality. International firms have access to training resources through the Kentucky Community and Technical College System which supports over 5,000 companies annually and can also benefit from our statewide apprenticeship style training program the Kentucky Federation for Advanced Manufacturing Education (KY FAME) to ensure a strong pipeline of qualified employees.

Italian Investment in Kentucky

Kentucky welcomes international investment and is already home to over 200 European firms supported from its European Office in Hamburg, Germany. This includes 11 Italian companies that employ 2,057. Recent investments include Perfetti van Melle's production expansion creating 70 new jobs and investing \$11 million.
